## 1. Call to Order

## 3a. RI USDA- NRCS State Conservationist

Jameson submitted a report but did not attend. An oyster specialist has been hired as well as a soil conservationist.

# **3b. RI Association of Conservation Districts**

Phil M. attended the last meeting. The audit of RIACD's books took place and essentially it went well and was reflective of the budget. However, improvements to the process could be made including switching from an accrual to a cash basis as well as improving the approval process for cutting checks. Also, there needs to be more consistency across the three districts. Molly Allard is putting operational procedures together to run by the board. Cassius S. will continue to serve as RIACD President. Cassius S. needs to at least be an associate SRICD board member to serve on RIACD. Phil M. will have a conversation with Cassius S.

# **3c. RI State Conservation Committee**

There is a meeting on 11/21/24. Gina F. will attend and will bring the ballots from the election. Ashlee B. is willing to be a representative on the committee.

## 3d. District Manager

Fresh Harvest Kitchen successfully passed the fin fish and shellfish licensing process. The business/bookkeeping position needs to be brought up at the RIACD level. Gina F. is looking into refocusing efforts at FHK on commissary kitchen services and no longer hold the DEM licenses.

## **Financial Report**

Phil M. motioned to certify the election results to be forwarded to the RI state conservation committee for certification. Katy K. seconded. The motion passed unanimously.

Phil M. made a motion that Gina F. recommend to the state committee that Ashlee B. and Clark C. be appointed by the state committee to the Southern RI Conservation District Board. Gina F. will transmit the petitions with the required 25 or more signatures to the RISCC. Katy K. seconded. The motion passed unanimously. Phil M. made a motion to recommend that Ashlee B. be appointed as our representative for the Southern Rhode Island Conservation District to the Rhode Island State Conservation Committee. Katy K. seconded the motion. The motion passed unanimously.
